Annual Convocation and Mona Sherman Memorial Lecture

OLLI's Annual Meeting was held at The Colonial Theatre on May 21, 2010. Howard Arkans, President of OLLI, opened the proceedings by welcoming members and thanking OLLI's cultural partner, The Colonial Theatre, for hosting the event. He introduced OLLI Executive Director, Barbara Hochberg, who thanked the volunteers whose efforts and support help the organization. She also acknowledged the contributions of OLLI's Educational Partners, addressing not only their assistance in making facilities available for classes, but also for their instructional and technical support.

President Arkans then called the Business Meeting to order. He acknowledged Bob Desrosiers for his ongoing technical contributions to OLLI, noting his efforts in establishing the Video Conferencing System. He pointed out that OLLI's membership has grown to 952, but the organization needs 1,000 members in order to apply for a second endowment gift of \$1 million from The Bernard

Osher Foundation. He encouraged all assembled to recruit new members.

Norman Michaels, OLLI treasurer, presented the Financial Report and projected a surplus of \$56,340 for the fiscal year ending June 30, 2010.

President Arkans next presented four resolutions, each of which constituted changes to the OLLI at BCC Bylaws. The first resolution refers to the fact that the Executive Director is responsible both to the BCC Lifelong Learning and Workforce Development Deans and to the OLLI at BCC Board of Directors: the second resolution states that the President of the Board shall preside as Chair of the **Executive Support and Appraisal Team** and be a member of the Governance Committee; the third change states that the Legal Advisor can serve as the only non-voting ex-officio member of the Board; and finally all reference to a Parliamentarian shall be eliminated from the Bylaws. The changes were passed unanimously.

President Arkans next presented the slate of new and existing members

of the OLLI Board of Directors which includes new members: Ruth Degenhardt, Robert Rosen and Ronald Stewart and existing members: Marilyn Brimberg, Bonnie Desrosiers, Joe Gerard, Norma Leavey, Norman Michaels, Wilma Michaels and Arthur Sherman. A vote was called and the slate was approved unanimously.

Following the business meeting, Lisa Starkey, Mona Sherman's daughter, introduced Jane Velez-Mitchell, the host of HLN's "Issues with Jane Velez-Mitchell" and speaker for the Second Mona Sherman Memorial Lecture. Lisa's opening remarks included a tribute to her mother and her dedication to OLLI. The subject of the Ms. Velez-Mitchell's lecture was "Addict Nation." After describing her own background and interest in the subject, she spoke of the many "addictions" from which society suffers ranging from alcoholism to drugs to food and overconsumption of consumer goods. Ms Velez-Mitchell's passion for her topic moved the audience to continue the dialogue after the meeting.

OLLI at BCC Mentoring Program

In the spring of 2009, a small committed group of OLLI members met to consider the idea of a mentoring program that would match OLLI mentors with Berkshire Community College students who were exploring career options. That meeting was followed with a luncheon to discuss the concept with senior BCC faculty from disciplines across the curriculum. Later, a similar meeting was held with BCC students to ascertain how a mentor might have benefited them.

In the fall of 2009, a pilot program was launched. Dr. Carole Siegel, an OLLI member with a great deal of professional mentoring experience, chaired the program. A Mission Statement was adopted by a committee that included OLLI members, BCC faculty and the Dean of Academic Affairs at the College. It states:

The mission is to provide BCC students who are exploring career choices with the framework for productive relationships with professionals from those career paths. These relationships will allow students to make positive connections between baccalaureate and graduate education, the world of work and their BCC experience. Students will be assisted in developing personal skills and awareness of the marketplace to assist them in making wise career decisions.

Throughout the fall and spring 2010 semesters, seven mentors worked with students to help them realize the complexities of the workplace and the options involved in careers ranging from health to education to social work. They met with students on an average of twice a month for an hour to two hours. This pilot phase encountered problems and successes

and has helped inform the evolution of the program.

The OLLI at BCC Mentoring Program must grow in a measured way. The need for professional college staff to administer the program, the need for a sophisticated training program for mentors and the desire to make sure that we launch this enterprise correctly are mandating our cautious start. For these reasons, we are not yet ready to issue an official call for mentors. Please explain why you are interested, verify that you would be willing to attend mentor training sessions and state your career expertise.

Art Sherman Receives BCC President's Award

Berkshire Community College's 2010 President's Award was presented at the 50th Commencement Exercises on June 4 to Art Sherman in recognition of his remarkable effort and success in obtaining support from The Bernard Osher Foundation for the transformation of BILL into OLLI at BCC. He accomplished this jointly with his late wife, Mona Sherman. Art was also recognized for lending expertise and direction toward the establishment of the mentor program for BCC students. Art is a former President of BILL.



Edna St. Vincent Millay

Edna St. Vincent Millay wrote "My candle burns at both ends," a line which in some measure captures the spirit, brilliance and philosophy of her poetry and life. Millay's story, as reflected in her poetry, is one of adventure, selfexpression, love, freedom and concern for others. She stirred her generation to defy tradition and in the twenties she became a popular poet among students on college campuses and with the Bohemian set in Greenwich Village. In 1923 she became the first woman to win the Pulitzer Prize for poetry for The Harp-Weaver and Other Poems. Later during the period between World War I and the beginning of World War II in Europe, she added social justice and international concerns to her themes.


Edna St. Vincent Millay was born in Rockland, Maine, in 1892. Her mother inspired her to begin writing poetry, and a children's magazine published her first poems when she was fourteen. At nineteen she wrote "Renascence" for a contest. She did not win; however, "Renascence" was

later published in The *Lyric Year*. It was recognized by literary critics and led to her receiving a scholarship to Vassar College in 1913. She was older than her classmates and, according to *The Vassar Encyclopedia*, she developed a reputation for breaking college rules and almost failed to graduate. However, the

faculty signed a petition that allowed her to receive her degree but denied her permission to participate in the graduation ceremonies even though the program included singing the "Baccalaureate Hymn" which she had composed.

After Vassar and her Greenwich Village life, she traveled in the United States and around the world writing and reading her work which included popular stories written under the pen name Nancy Boyd. In 1923

she married Eugen van Boissevain, a business man, and in 1925 they came to the Berkshires. Theirs was



Millay's interest in social themes remained and in her later years

she wrote a book-length poem: *The Murder of Lidice* about Nazi atrocities in Czechoslovakia, which was broadcast in Europe.

Millay's home, history and work are preserved at nearby Steepletop which was named a National Historic Landmark in 1971. Tours of her gardens and home, including the Poet's Walk that leads to her grave, are open to the public through mid-October.
